1. Mission

3. Teaching & Learning: Quality Resources and Support



4. Teaching & Learning: **Evaluation and Improvement** 



5. Resources, Planning, and Institutional Effectiveness



There are five criteria that the HLC uses to determine whether an institution is delivering a quality education. These criteria include all functions of the institution from the mission and the delivery of the mission to teaching and learning, and governance. Each criterion has several core components (two to seven in most cases). The table on the next page demonstrates which components will be especially emphasized during the upcoming HLC visit.

### The HLC Visit is on April 27-28

The upcoming visit is a Focused Visit, which means that while the team can and will likely ask about any aspect of the college, but they will focus on the criteria which the college either did not meet or met with concerns. The November 2019 issue of the Assessment Newsletter contains information on which criteria the college did not meet or met with concerns.



### **Assurance Argument Writing: Progress Report**

Currently, we are in the process of writing the LLTC Assurance Argument, which will be submitted to the HLC on March 1, 2020 in advance of the April 2020 visit. Below is the progress of writing and evidence gatherting as of 1/31/2020. Note that evidence gathered percentage indicates what percent of evidence has been located, not what percent exits.

Criterion	Percent Writing Progress	Evidence Gathered
1	90%	100%
2	0%	0%
3	40%	60%
4	90%	90%
5	0%	40%



#### Why should you care about the HLC visit?

Accreditation by a nationally recognized accrediting body assures the public, the community, and prospective students that our college meets standards based on the five accreditation criteria: mission; integrity; teaching and learning quality, resources and support; teaching and learning evaluation and improvement; and resources, planning and effectiveness. This accreditation is also how LLTC is eligible for federal financial aid and support, and ensures our credits transfer to other institutions.

### How can you support the HLC review / visit?

- Read the Assurance Argument, which will be abailable on the LLTC website and will be sent via email to the campus on or around March 1.
- Attend Friday Accreditation meetings
- Know LLTC's mission, core values, and Institutional Learning Outcomes.
- Review information you will be receiving in the upcoming months in the email and during Friday meetings
- Be prepared for an HLC representative to ask you questions during the visit.
